



1. The engagement will be purely on temporary contractual basis and in no way seeking for regularization of service will be entertained or accepted on completion of the contractual engagement agreement period.
2. The engagement period would be initially one year from the date of joining into service with a monthly fixed remuneration of Rs.10,000 (Rupees Ten thousand) only and may be extended further by giving a gap of one day as per the requirement and discretionary decision of the Dima Hasao Autonomous Council authority subject to the performance assessment or review of the engaged teacher conduct.
3. No paid leave other than Casual Leave for 10 days in one contractual engagement period will be entitled.




